Crete Academy provided several opportunities for stakeholder input during public forums. Families, students, school administrators, school staff and teachers, including special education teachers reviewed the ESSER III plan during the October Monthly Parent Meeting. Translation for non-English speaking individuals was provided, as needed. Because Crete serves a large percentage of students experiencing homelessness, the school Principal and Assistant Principal, who mange the school's Wellness Center and provide services targeted at foster youth and those experiencing homelessness, were heavily engaged in the development of the ESSER III plan. Additionally, the Director of Special Education, whose primary role is to serve students with disabilities, was also included in the development of the plan.

The spending plan was shared and individuals asked questions and provided feedback regarding the plan. Additionally, the community was provided an opportunity to give feedback on the ESSERR III Plan, during the October Board Meeting.

Crete Academy's stakeholder group does not include tribes, civil rights organizations and disability rights organizations.
