#### **Consent Items**

1. Updated 2024-2025 Family Handbook

In preparation for the 2024-2025 school year the Crete Academy Family Handbook has been updated with an attendance incentive for students with chronic absences. Crete Academy is focused on academic advancement for all students and those with chronic absences academic tutoring will be a priority over field trips.

### 2. Updated 2024-2025 Employee Handbook

## 3. Cash Flow Loan

The leadership at Crete is seeking approval of the Board of Directors to assume a \$2M loan from a bank to assist with cash flow and to use towards investments including purchase of a property to expand the Crete mission.

### 4. ETK Funding

The leadership of Crete finds it necessary to apply to the state for the funding of ETK. Crete leadership understands the importance of enrolling the earliest learners and exposing them to social opportunities and early curriculum in reading, writing and arithmetic. Therefore, the leadership at Crete request board approval to apply for funding with the state of California to operate an ETK program.
